METHOD OF USE:

Preparation of Disinfection:

Firstly, required pesticide is mixed with some water in a container. The prepared mixture is added to the disinfection device tank that is full in half level with water. The tank is filled with water again and mixed. It is ready to perform disinfection. This mixture is sprayed all parts of the plant when the weather is calm and cool.

Disinfection Time:

Cotton: Separate the field in 4 pieces. In each part, take one leaf from 25 plants in every 10-15 step. Count on 100 leaves via a magnifying glass totally. The disinfection is performed if there are Red Spiders with the number of 5 in Mediterranean, 10 in Aegean and Southeast per leaf. Partial disinfection may be performed in case of side contamination. The water quantity for a decare must be determined via calibration according to the device to be used. And then required pesticide must be added. If tractor-mounted- ground devices will be used, inter-row nozzles must be used.

Tomato, Aubergine, Watermelon: Beginning from the first inflorescence, enter the field crossly from the edge. Count with magnifying glass totally 10-20 leaves by one leaf from bottom and intermediate leaves once in 3-5 steps. The disinfection is performed if there are 3 or 5 Red Spiders per leaf. The water quantity for a decare must be determined via calibration according to the device to be used. And then required pesticide must be added.

Strawberry: The disinfection is performed when 15 moveable things per leaf are visible from 50 leaves representing the field. If there are ripe fruits, obey the waiting time or perform the disinfection after collecting the fruits.

White fly: The disinfection is performed when you see 0.5-2 larva in May-June period; 2-3 larva in July-August period and 3 larva in September per leaf considering 50 leaves.

INFORMATION ON RESISTANCE:

The pesticide name **Koffex** is a fungicide classifies as Group 23 in accord with its action mechanism. Repeated applications of pesticides with same action mechanisms invite development of resistance. Therefore, to delay development of resistance, do not exceed the recommended number of **Koffex** applications in the same season. In case repeated application is necessary, take care to use pesticides with a different action mechanism (other than Group 23).

MISCIBILITY:

It may be mixed with many insecticides, fungicide and leaf fertilizer. But, premixture test must be performed before the application.
