**USAGE:**

**Mode of Action and Properties:**

It is a fungicide as protective and preventive effect, contact, translaminar and locally systemic carried. It is a pesticide combined effects of boscalid and Pyraclostrobin, providing a high level control and having the shape of two different domains comprises the active ingredient contents appropriate resistance management and IPM. There is a good lasting effect.

**Preparation of Pesticide:** Recommended dose pesticide is mixed with water in a separate container. It is stirred into tank spraying device halfway full of water.

**APPLICATION METHOD and TIME:**

**Gray Mold on Tomato:** The dressing should be started when The first symptoms of the disease is seen or in the period 2-3 raceme grown on tomatoes. The dressing is repeated 10-12 days apart according to the ecological conditions and course of the disease.

**Powdery Mildew On Tomato:** The dressing should be started when The first symptoms of the disease is seen. The dressing is repeated according to the ecological conditions and course of the disease.

**Gray Mold on Pepper:** The dressing should be started when The first symptoms of the disease is seen or in the period of blooming. The dressing is repeated according to the ecological conditions and course of the disease.

**Monilia on Apricot:** 1. Dressing in the period of beginning of blooming (%5-10 flower), Second dressing: full of blooming (%90 – 100 flower).

**INFORMATION ABOUT RESISTANCE:**

Bellum named plant protection products according to its mechanism of action is classified as Group 7:C2-11;C3. Repetitive applications of plant protection products with the same mechanism of action, encourages the development of resistance. For this reason, to delay development of resistance in Bellum on the same production season, the number of applications exceeds the recommended total. In cases where the application should be repeated, with a different mechanism of action (Group 7:C2-11;C3 external) careful use of plant protection products.

**MIXING CASES:** A germination test should be performed first, if the mixture. It is recommended to use mixtures without delay.
