### 4. FIRST AID MEASURES

**Poisoning Symptoms:** May cause nausea, vomiting, headache and corrosion of the organs.

**First Aid Measures:** In case of poisoning please stop working and contact with a doctor. In case of contact with skin or eyes, wash with plenty of water. In case contact with eye, wash with plenty of water minimum 10 minutes. In case inhale, remove the patient to fresh air. If swallowed, give medical coal with plenty of water. If swallowed large amount of concentrated medicine, call for medical assistance. Note: Do not give anything by mouth to unconscious patients.

## 6. ACCIDENTAL RELEASE MEASURES

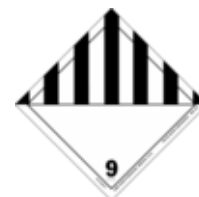
