#### USAGE:

##### Preparation of the pesticides to be applied:

Before the pesticide is mixed with a small amount of clean water thoroughly. After this mixture is put into half filled with water to the tank. While string , the water level is completed. The mixture should be stirred well and it should be used within a few hours. The mixing process is continued until spraying is completed. The mixture more than necessary should not prepare.

##### The calibration of sprayer tool:

Before spraying , instrument must be calibrated in accordance. To determine the amount of composition to be used, before plants are soaked in a particular area with only water or trees certain number. Spent water is calculated by determining to per tree or per decare.

##### Application time:

At least 20 L of water should be used for da. and the soil surface to be wetted correctly. Soil should not be treated in the coming days and kept moist soil. If you do drip irrigation, filter should be used in irrigation.
